About the Presidential Volunteer Service Award

Volunteer Eligibility:

- Must be United States citizen or lawful permanent resident of the United States (i.e., green card holder)
- Must be at least 5 years old
- Eligible service hours must be completed within a 12-month period (for annual Bronze, Silver and Gold Awards) and over a lifetime (for Lifetime Achievement Awards)

Eligible Service:

- Unpaid acts of volunteer service benefitting others
 - Service through National service programs that provide a stipend (e.g., Peace Corps, AmeriCorps) may count towards the Lifetime Achievement Award, but not for the annual Bronze, Silver, and Gold Awards)
 - Travel stipends, transit/parking passes, membership passes, expense reimbursements, and other nominal volunteer support do not impact service eligibility

Eligible Service does not include:

- Donating funds
- Political lobbying (Non-partisan voter registration is an eligible activity)
- Religious instruction (teaching, leading or participating in religious education)
- Conducting worship service (teaching, leading or participating in religious ceremonies/rituals)
- Proselytizing (activities intended to convert individuals to one or another belief system)
- Volunteer service performed as part of court-ordered community service
- Serving only family members

Hours Requirements:

Age Group	Bronze	Silver	Gold
Kids (5-10 yrs):	26-49 hours	50-74 hours	75+ hours
Teens (11-15 yrs):	50-74 hours	75-99 hours	100+ hours
Young Adults (16-25 yrs):	100-174 hours	175-249 hours	250+ hours
Adults (26+ yrs):	100-249 hours	175-499 hours	500+ hours

How to submit Service Hours to GSNCA for award:

This form is an hour log to help Girl Scouts track volunteer time throughout the year. Award recipients are responsible for ensuring complete information is submitted on the proper form by the deadline. Check the GSNCA website in January of the new year for the submission form or contact us at awards@girlscoutsnca.org.

All hours completed for the award must be submitted to GSNCA by January 31st of the new year to be reviewed and submitted for the previous year's award. No late submissions will be accepted.

GSNCA will certify PVSA hours for all active members but will purchase award pins for Girl Members only.
