

# 2025 Snack Sack Program (Direct Sale of Fall Program, Candy and Nuts)

Discover how Girl Scout Troops and Girl Scouts can participate in Snack Sacks Program (direct sale of fall program, candy and nuts) as part of the 2024 Girl Scouts of North-Central Alabama Fall Product Program. Snack Sacks offer a new way for troops and girls to reach their customers—with product **in-hand** during the Fall Product Program! We are excited to pilot this program and believe it will enhance the Fall Product Program by allowing Girl Scouts to participate in door-to-door sales and community booths!

**\*\* There is a limited number of Snack Sacks available. Orders will be filled on a first come, first serve basis. Order early!**

## Snack Sack Program Details

- Eliza's Trunk Bags are ordered by troops for girls to have product in-hand at the beginning of the Fall Product Program. All sack items will be entered into M2 by Council at the end of the sale and the TFPM will distribute to the girls to earn rewards.
- For troops that order sacks, the items will be entered on the "Extra Product" line and payment will be due with Fall Product payments. Troops will then need to move items to participating girls.
- Individual Girl Scouts may also sign up for the Trunks but will be required to pay for the bags when picked up. Council staff will then enter these payments into M2 and credit the troop for the Girl Scout.

## How it Works

- Customers can pay for the sack products using cash or check. If a customer only has a credit card to use, an order for Girl Delivery or Direct Ship must be completed. **Credit cards cannot be accepted through the M2 platform for these items.** If the troop has a process to accept credit cards or other on-line payments, the troop can be paid directly.
- Parents/TPMs do not need to add these items in M2 – items will be loaded into the M2 System by Council.

## Rewards

The Snack Sacks contain a variety of Fall Product nut and candy items that will be counted towards Girl Scout Rewards earned during the 2025 Fall Product Program. These items will automatically be calculated in the M2 System for Girl Scouts who sign up to participate in the Program.

## FAQ

**Q:** Who can participate in Snack Sack Program?

**A:** Any Girl Scout troop or any registered Girl Scout can participate in the Snack Sack Program.

**Q:** How do I sign up to participate in Snack Sack Program?

**A:** Troop leaders or TFPMs, parents/guardians can [sign-up between July 20 - August 20 HERE:](#)

**Q:** Can my Girl Scout sign up to receive multiple Sacks?

**A:** Yes! If your Girl Scout has big goals this Fall Product season and would like to request more than one Snack Sack, you may do so. Remember, the sacks must be paid for when they are picked up.

**Q:** I signed up to receive a Snack Sack. Where is it?

**A:** Trunk Bag pick-ups begin the week of September 22 during open shop/office hours. Days and times of pick-ups for Girl and Troop participants will be sent in early September.

**Q:** Can I return any unsold items from my Snack Sack?

**A:** Unsold items MAY NOT be returned. Once you pick up and sign the product receipt, it is your financial responsibility.

**Q:** Can I exchange any unsold items for a different item?

**A:** Exchanges are NOT allowed. Each Sack contains a carefully selected lineup of our Fall Product Program best-selling items.

**Q:** I received a Snack Sack and I have a damaged item. What do I do?

**Q:** How do I accept payment from my customers when selling items in the Snack Sack?

**A:** Payments may be accepted via cash/check. At this time, credit card payments cannot be accepted through the M2 site for Snack Sack items. If your customer would like to pay with a credit card, you will need to have them order online, through the M2 system, selecting either the Girl Delivery or Direct Ship option. **They can order the same items, but you can't use your Snack Bag inventory to fill the order when they need to pay with a credit card.**

- For troops - if the troop has a process to accept credit cards or other on-line payments, the troop can be paid directly.

**Q:** When and how will I be charged for the Snack Bags?

**A: For Troops:** The amount will be added to the troop account when the items are added at the end of the program.

**For Girl Scouts** – Parent/Guardian will pay for the Snack Bag when it is picked up. Credit for that payment will be posted to the troop account in M2.
