 In-person sales end. All money is due to Troop Product Manager (TPM).

#### **PROGRAM DETAILS**

#### FOR TROOPS

- Order Snack Sacks for girls to have product in hand at the beginning of the Fall Product Program. All items will be entered into M2 by council staff at the end of the sale, and the TFPM will distribute them to the girls to earn rewards.
- Snack Sack items will be entered on the "Extra Product" line, and payment will be due with Fall Product payments. Troops will then need to move items to the participating girls.

# FOR INDIVIDUAL GIRLS

 Individual girls will be required to pay for items in Snack Sacks upon pick-up. Council staff will enter these payments into M2 and credit the troop for the Girl Scout.

#### **HOW IT WORKS**

- Customers can pay for Snack Sack products
  using cash or check. Credit cards cannot be
  accepted through the M2 platform for these
  items. If a customer would like to pay with a
  credit card, have them order online through M2,
  selecting either Girl Delivery or Direct Ship. They
  can order the same items, but you can't use
  your Snack Sack inventory to fill the order
  when they need to pay with a credit card.
- If the troop accepts credit cards or other online payments (such as Venmo, PayPal, or Cash App), the troop can be paid directly.
- Parents/TFPMs do not need to add these items in M2. The council will enter the items.

#### HANDLING MONEY

 All money (cash and checks) from troop-ordered bags is due to the TFPM by October 29. TFPMs will receive an email by the end of September informing them of any girls in their troop who are participating in the Snack Sack program. For any girl-ordered Sacks, GSNCA will enter the payments to the troop.
